Required by May 16 from ALL applicants:

FAFSA

Complete a **Free Application for Federal Student Aid (FAFSA) or Renewal FAFSA**. The FAFSA may be completed online at www.fafsa.ed.gov. If you prefer a paper version, you may call 800-4FED-AID to request a paper version of the FAFSA. List Macalester (school code 002358) in the school release section of the FAFSA.

Required by May 16 from SOME applicants:

For many applicants, the FAFSA is the only required form. However,

- 1. if your FAFSA is selected for verification^{*} by the Department of Education, OR
- 2. if you have a change in circumstance that you would like to tell us about, OR
- 3. if you will have a sibling enrolled in college as an undergraduate during 2011-2012, then

you must provide the documents listed below as part of your financial aid application. Mail or fax these items to the Financial Aid Office at the address above.

- Complete the **2011-2012 Macalester Financial Aid Application** (this document) and return it to the Financial Aid Office.
- Send a signed photocopy of your custodial **parent's 2010 federal income tax return & all W2 form(s)** to the Financial Aid Office. If your custodial parent was not required to file a 2010 tax return, s/he must complete the non-filer statement found in section C of this document.
- Send a signed photocopy of **your 2010 federal tax return** to the Financial Aid Office. *If you were not required to file a 2010 federal tax return* you must complete the non-filer statement found in section B of this document.

^{*}Review your FAFSA results to determine whether your FAFSA has been selected for verification. After your FAFSA has been processed, you may also log in to 1600grand.macalester.edu to review items that are required to complete your financial aid application.
