# 2025 J-term Live It Fund Program Application

With J-Term awards (up to \$2,000 project reimbursement funding), the purpose of the Live It Program is to give Macalester students an opportunity to live out their definition of global citizenship by proposing innovative solutions to problems and opportunities they identify. Who is eligible to apply?

- Students enrolled full-time at Macalester College in the Spring 2025 may apply.
- Students who are studying abroad for the Spring 2025 semester may apply, but you must be able to video call for any required interviews or meetings.
- Students may apply solo or in teams of 2 people. Both members of your team must follow the eligibility requirements.
- If you are a senior graduating at the end of the fall semester, you must partner with a student who will be at Macalester the entire academic year to be eligible to apply.
   Someone needs to be enrolled during the spring semester to participate in all of the follow-up Live It Fund requirements that take place after J-Term is over.

Within this application, you will be asked for your consent to allow the Department of Entrepreneurship and Innovation, to contact the Office of Student Affairs, the Registrar, Academic Programs, and Title IX to inquire about your disciplinary and academic status with the college. Current or past violations do not necessarily mean you will be excluded from this selection process; however, they may be taken into consideration. You will also be asked for consent to authorize the Macalester College Financial Aid Office to disclose information to the Entrepreneurship at Macalester for the purpose of consideration for Live It Fund. The Family Educational Rights and Privacy Act (FERPA) (20 U.S.C. § 1232g; 34 CFR Part 99) is a Federal law that protects the privacy of student education records. Schools must have written permission to release student record information. For the purposes of this grant process, Financial Aid will only release information about your level of demonstrated need for financial aid. Details of your financial aid application will not be shared. By consenting to this release, you the student, certify that you are granting the Financial Aid Office permission to release your financial need information to be considered for Live It Fund.

Your application will be kept confidential throughout the entire process, but it will be shared internally within the Department of Entrepreneurship and Innovation as well as with the relevant selection committees. The selection committees are required to keep all application and selection materials confidential. We retain the right to share your application or portions of your application to various departments and committees within the college including, but not limited to, International Student Programs, Institutional Research, and the Institutional Review Board committee.

It's can be messy but clarity comes with action and practice. **Important Note**: Entrepreneurship is all around us. Every student (that means you!) has the ability to think and act entrepreneurially, envision possibility, transform opportunity, and create impact.

Play and experimentation can unlock innovative insights, while reflection will allow you to assess your progress, learn from setbacks, and iterate on your ideas. Ultimately, this process will help you develop resilience and work toward a meaningful solution.
